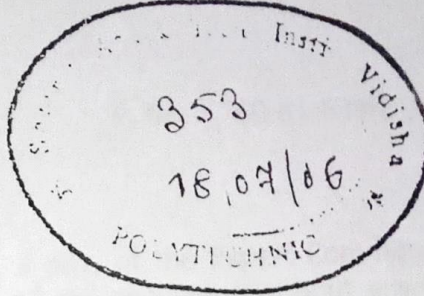


Admission will be made in accordance with Regulations notified by the AICTE vide GSR 476 (E) dated 20 May 1994 based on the Hon'ble Supreme Court Judgment dated 4 December 1993 with regard to WP (C) No. 607 of 1992 in the case of Unni Krishnan JP and Others etc. versus State Government of Andhra Pradesh and Others etc. and later judgments. No Management, Institute, Trust or Society shall announce admission directly under any circumstances. Any action contrary to this provision taken by the Institute will make it liable to be derecognised.

Further, in the event of infringement or contravention or non-compliance of the norms and standards prescribed by the AICTE during the last approved academic year, the Council shall take further action to withdraw approval in this case for admission during subsequent academic year, and the liability arising out of such withdrawal of approval will be solely that of the Management, Trust, Society or Institution. The Institute shall not use the same infrastructure meant for these approved diploma programmes, for any other academic programme (s) simultaneously.

The Council reserves the right to visit the institution at any time it may deem fit to note the progress.

You are requested to kindly monitor the progress made by this Institution for fulfillment of the Norms and Standards of the Council, and Keep the concerned Regional Committee and AICTE informed.


