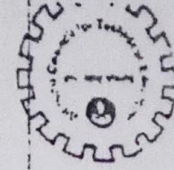

No Management / Institute / Trust / Society shall announce admissions directly under any circumstances. Any action contrary to this provision taken by the Institute will make it liable to derecognized.

Further, in the event of infringement / contravention or non-compliance of the norms and standards prescribed by the AICTE during the last approved academic year, the Council shall take further action to withdraw approval to this case for admission during subsequent academic year and the liability arising out of such withdrawal of approval will be solely that of Management / Trust / Society and / or Institutions.

The Council reserves the right to visit the institution any time it may deem fit to verify the compliance of Norms and Standards of AICTE.
